# REAPPOINTMENT OF THE PUBLIC REPRESENTATIVE MEMBER TO THE SETA GOVERNING BOARD

#### **BACKGROUND**:

#### **BACKGROUND:**

The Executive Director is requesting Board approval to modify the salary range for the Purchasing Analyst job classification. The purpose is to adjust the salary range so that the internal relationship is maintained with other supervisors with similar duties, responsibilities, and span of control. This positions and the incumbent is an unrepresented confidential employee.

The Purchasing Analyst job classification was created in June 1998. The incumbent is responsible for the purchasing function of the Agency and the supervision of staff.

<u>Fiscal Impact:</u> Five (5) per cent increase in the salary range; annual fiscal impact of \$2,300.

#### ITEM III-C - 1 - ACTION

#### APPROVAL OF AUGMENTATION TO ELK GROVE UNIFIED SCHOOL DISTRICT

#### **BACKGROUND**:

SETA's Children and Families Department is seeking approval to augment Elk Grove Unified School District's Head Start Program from 260 children and families to 300. The augmentation, if approved, is a result of transferring 40 funded slots from the SETA Operated Program to Elk Grove. Augmented slots will go to Prairie Elementary where they have an available classroom as well as Home Based services.

The total amount of funds to be transferred is \$199,728, representing a ten-month allocation.

The SETA program has decreased 20 funded slots from the Center of Praise (Rancho Cordova) site and 20 slots from Nedra Court. We believe this request will ensure slots are filled immediately with minimal impact on the SETA Operated program.

The Head Start Policy Council reviewed and approved this item at their October 26, 2004 meeting. Staff will be available to answer questions.

### **RECOMMENDATION:**

Approve the above augmentation of \$199,728 to the Elk Grove Unified School District to increase their Head Start funded enrollment from 260 to 300.
