I. Call to Order/Roll Call/Pledge of Allegiance: Mr. Robbie Waters called the meeting to order at 10:11 a.m.

II. Consent Items

The consent calendar included approval of minutes of the January 20, 2005 regular board meeting and approval of claims and warrants for the period 1/14/05 to 1/27/05. There were no questions or comments.

B. WORKFORCE INVESTMENT ACT

 Appointment of Economic Development Member to the Sacramento Works, Inc. Board

Ms. Kossick reported that the Sacramento Works Executive Committee is recommending the appointment of Walter DiMantova for the Economic Development sector slot.

Moved/Pannell, second/Scherman, to appoint Mr. Walter DiMantova to an Economic Development sector slot on the Workforce Investment Board operating as Sacramento Works, Inc.

Voice vote: Unanimous approval.

2. Appointment of Youth Council Members

Ms. Christine Welsch stated that all of the applicants are graduates of our program or the Casey programs. The applicants were interviewed by several members of the Youth Council and Julie Davis-Jaffe. The applicants range in age from 15 to 20 years.

Mr. Nottoli arrives at 10:17 a.m.

Moved/Pannell, second/Scherman, to appoint Matthew Avery, Brittany Hall, and Kamika Whetstone to the Sacramento Works Youth Council. Voice Vote: Unanimous approval.

C. HEAD START

 Approval to Apply for State Department of Education Child Care and State Preschool Expansion Funds

Ms. Norma Johnson stated that this item requests additional funds and can be 'wrapped around' some Head Start services.

Ms. Collin arrived at 10:21 a.m.

Ms. Johnson stated that all of the sites are being reviewed to see where expansion could be achieved. Ms. Pannell stated that it is important to expand the full day programs to serve more children.

Moved/Panel, second/Scherman, to approve the submission of an application to the State Department of Education, Child Development Division for expansion of full- and part-day services to children and families.

Voice Vote: Unanimous approval.

In response to a question as to how many more children will be served, Ms. Johnson stated that 76 more children will be served in general child care and 80 in State Preschool.

IV. Information Items

- A. Fiscal Monitoring Reports: No questions.
- B. Workforce Investment Act Reauthorization: Ms. Purdy reviewed this item. She stated that HR27 was introduced called the "Job Training Improvement Act" and another called "The Life-Long Education Act" which also deals with WIA. The biggest changes proposed will be in the youth program. The emphasis of the WIA will change to serve out-of-school youth, particularly high-risk. An update will be given to the board in advance of the capitol-to-capitol trip.
- C. California Head Start Fact Sheet: Ms. Johnson stated that this gives a picture of Head Start on a national level. She is hoping to have information on the Head Start reauthorization later this month. Sixty-six percent of California Head Start children are of Hispanic heritage.

- B. Executive Director: Ms. Kossick reminded the board that this coming Saturday is the beginning of the Voluntary Income Tax Assistance program. Career centers and program operators will be offering this service until April 15.
 - Ms. Kossick provided a gift to Mr. Nottoli as out-going chair. It was a colorful tie of children's hands.
- C. Counsel: Mr. Larry Larsen talked about Pat Cooke's retirement on February 4. Mr. Larsen stated that Ms. Cooke has been integral to the success of the agency. She has been an excellent source of support to legal counsel.
- D. Members of the Board: Ms. Collin reported that February 9 is the Chinese New Year, which will be the year of the rooster. A program will be held at CSUS and it covers all Asian cultural things.
 - Ms. Pannell announced the Sweet Potato Festival which will be at the Pannell Center.
- E. Public: Ms. Christine Welsch spoke about the WIA reauthorization, specifically regarding youth funds. The Youth Council has been struggling with the aspect of dealing with the flip of needs from in-school youth to out-of-school youth. The Youth Council will continue to look at this issue over the coming months.

ITEM III-A – 1 - ACTION

APPROVAL OF SELECTION OF AUDIT FIRM

BACKGROUND:

On December 17, 2004, SETA released a Request for Proposals (RFP) for Audit Services. The audit services contract will be granted for one year and may be extended by SETA for two additional one-year terms.

SETA's fiscal staff conducted the following procurement:

December 23, 2004 - Mailed copies of the Public Notice to 123 Accounting firms. A Public Notice announcement was printed in the Sacramento <u>Bee</u> on December 23, 2004, December 27, 2004 and January 3, 2005. The RFP was also available to download from SETA 's website.

January 10, 2005 - Held a proposers' conference with six Accounting firms in attendance.

February 10, 2005 - Received three final proposals, from Damore Hamric & Schneider, Inc., Gilbert Associates, Inc. and Carlos E. Soler- Certified Public Accountant. Received telephone call from Ernst & Young stating their firm would not be able to participate.

The proposal review team consisted of two individuals from the County Department of Finance and two staff from SETA's Fiscal Department.

After careful consideration of each firm's audit experience, size and structure, qualifications of staff, responsiveness and fees, the proposal review team has recommended that the contract be awarded to Gilbert Associates, Inc. Gilbert Associates has an audit team with extensive background in government and non-profit accounting including the implementation of the Governmental Accounting Standards Board issued Statement No. 34, Basic Financial Statements-and Management Discussion and Analysis-For State and Local Governments.

RECOMMENDATION:

Approve the selection of Gilbert Associates, Inc. for audit services for SETA for the fiscal year ending June 30, 2005 for the fee not to exceed \$29,000.

ITEM III-A - 2 - ACTION

APPROVAL TO SUBMIT QUOTE FOR SMARTWARE SERVICES TO THE COUNTY OF MERCED

BACKGROUND:

In December of 2003, the Sacramento Employment and Training Agency purchased the SMARTware Client Tracking and Case Management System from the Shasta County Private Industry Council. Since the purchase, SETA has provided both administrative and technical support to the five (5) SMARTware Users throughout the State, including Riverside County, Napa County, East Bay Works, Golden Sierra Job Training Agency and Yolo County Department of Employment and Social Services.

SETA staff has been contacted by the Merced County Department of Workforce Investment requesting that we provide them with a quote for the cost of adding them to the consortium utilizing the SMARTware system. SETA staff is currently developing a quote which will include the use of the software, hosting their data on a SETA–owned server, customization of the system, technical support, training and limited help desk support. Staff believe that based on discussions with Merced staff regarding their programmatic and technical requirements, the SMARTware system will meet the needs of this organization. This is an opportunity to generate additional revenue allowing for further development of the SMARTware system.

RECOMMENDATION:

Staff is requesting that your Board approve their request to submit a proposal to the Merced County Department of Workforce Investment for a SMARTware Client Tracking and Case Management System license.

ITEM III-A - 3- ACTION

APPROVAL TO SUBMIT PROPOSALS TO THE COUNTY DEPARTMENT OF HUMAN ASSISTANCE, PROGRAM YEAR 2005-2006

BACKGROUND:

The County Department of Human Assistance (DHA) recently released a RFP for Job Club/Job Search services for CalWORKs recipients. The RFP is limited to the areas serviced by DHA's Grand Oaks (ZIP codes: 95610, 95611, 95621, 95628 and 95662) and Research (zip codes: 95652, 95833, 95834 and 95838) Bureaus. The proposal deadline is Monday, March 21, 2005.

SETA is requesting approval to submit a proposal in response to DHA's RFP. SETA has provided job club/job search services through a contract with the Sacramento County Department of Human Assistance for the past three years to provide services for the Grand Oaks DHA office at the Hillsdale Career Center and on-site at the Rancho Cordova DHA Bureau. This RFP is seeking to continue services for the Grand Oaks Bureau, discontinue services in Rancho Cordova and establish job club/job search services for the Research Drive bureau.

If funded, staff is requesting approval for SETA's Executive Director to execute any DHA agreements, adjustments, modifications or other documents required by DHA.

RECOMMENDATION:

Approve the submission of a proposal to the County Department of Human Assistance, and authorize SETA's Executive Director to execute any DHA agreements, adjustments, modifications or other documents required by DHA.

Findings and General Observations:

- 1. The total costs as reported to SETA from September 30, 2003 to September 29, 2004 have been traced to the delegate agency records. The records were verified and appeared to be in order.
- 2. A review of the Personnel Activity Reports (PARs) for September and August, 2004 showed several instances of variances between the time allocation and the payroll allocation. The variances did not have any financial impact on Head Start as the negative variances were offset by the positive variances. It is recommended that the PARs be reviewed to reconcile the payroll allocation with the time allocation.
