2. Approval of Minutes of the April 25, 2006 meeting

ITEM - 3- ACTION

APPROVAL OF EXPANDING THE NUMBER OF DIRECTORS ON THE WIB

BACKGROUND:

Section 3.01 of the Bylaws of Sacramento Works, Inc. states that the corporation shall have not less than 36 nor more than 50 directors and that "the exact number of directors shall be fixed, within the limits specified, by action of the Board of Directors." The current number of directors is 37. The board was increased by one Labor Sector representative on January 28, 2004.

There are three Education Sector slots, all currently filled (Grant Joint Union High School District, Los Rios Community College District, and Sacramento City Unified School District).

David Gordon, Superintendent, Sacramento County Office of Education, has submitted an application to serve on the Sacramento Works board.

By increasing the board size by two (from 37 to 39—increasing the board composition by one education representative and one private sector representative), the majority of the Board members would still be from the Private Business Sector (20 seats).

The actual designation of the additional seat as an Education Sector seat would need the approval of the SETA Governing Board, who actually makes the appointments.

RECOMMENDATION:

Hear an oral report and approve the increase of two seats (one Education and one Private Business) for the Sacramento Works, Inc. Board.

APPROVAL OF WORKFORCE INVESTMENT ACT MODIFICATION TO EXTEND THE STRATEGIC FIVE-YEAR PLAN FOR THE SACRAMENTO WORKFORCE INVESTMENT AREA FISCAL YEAR 2006-07

BACKGROUND

The State of California, Employment Development Department is requiring Workforce Investment Areas to submit modifications to their Strategic Five-Year Local Plans. The Sacramento Five-Year Local Plan was initially approved on March 16, 2000. Updates and modifications to the plan have been submitted to the state annually. For the Sacramento Workforce Investment Area, a Public Notice was issued on June 5, 2006 releasing the draft modification to extend the Strategic Five-Year Local Plan for public comment. Public comments must be submitted no later than July 5, 2006. The deadline for submission of the Local Plan modification to EDD is August 1, 2006.

The draft modification to extend the Strategic Five-Year Local Plan includes new items, items that were not submitted with the initial plan and/or subsequent year modifications and required planning forms.

- 2. Change of local board members and new Regional WIB
- 3. Addendum
- 4. Budget and Participant Plan Summary Forms
