ITEM 4 - ACTION

APPROVAL TO UTILIZE BOARD DISCRETIONARY FUNDS FOR PARTNERSHIP FOR PROSPERITY

BACKGROUND:

The Workforce Investment Board has given the Executive Committee the authority to approve funding for board discretionary items up to \$10,000 per project. In Fiscal Year 2006-2007, it is projected that \$323,701 will be available in Board Initiatives funding.

As many of the board members are aware, the Partnership for Prosperity has completed one year of work and has developed a Business Plan for the Sacramento Region concentrating on People, Place and Business. Sacramento Works has been a partner in this effort, and is a Champion in the area of High School Education and development of people.

Now that the Plan has been developed, the Action Teams will begin meeting to develop actions that produce results in each of the five areas identified in the plan. During this Implementation phase, Valley Vision will be continuing the role of facilitator for all of the Action Teams, tracing and coordinating progress. Each partner is being requested to continue the financial support for these efforts.

RECOMMENDATION:

Provide \$5,000 of Board discretionary funds this year and \$5,000 next year to continue with the implementation phase of the Partnership for Prosperity.

ITEM 5 - ACTION

APPROVAL TO UTILIZE BOARD DISCRETIONARY FUNDS FOR CONVERGENCE ON MATHEMATICS PREPAREDNESS AND ACHIEVEMENT

BACKGROUND:

The Workforce Investment Board has given the Executive Committee the authority to approve funding for board discretionary items up to \$10,000 per project. In Fiscal Year 2006-2007, it is projected that \$323,701 will be available in Board Initiatives funding.

Last fall, the Sacramento Works Ad Hoc Committee on Education developed an education policy and action plan that included sponsoring a Convergence that would bring together business, education and labor to identify the skills that are needed in the region's workforce and brainstorm innovative methods of teaching these skills to youth. Los Rios Community College District was also recently funded to bring together educators, business and labor in the region to collect and review information about math achievement in the Sacramento area, to convene math teachers and administrators, and to survey and describe business needs in the region for employees requiring math skills. This initiative will include a regional convergence on Mathematics Preparedness and Achievement to stimulate regional dialogue and identify skills gaps and project priorities relating to mathematics.

The collaborative working on math preparedness and achievement is requesting cosponsorship from Sacramento Works, Inc. in the form of funding for 50% of the costs of the Convergence, estimated to be \$12,000.

RECOMMENDATION:

Provide \$6,000 of Board discretionary funds to co-sponsor a region wide Convergence on Mathematics Preparedness and Achievement for education, business and labor.
