1. **Call to Order/Roll Call:** Mr. Kelly called the meeting to order at 8:36 a.m.

Mr. Brian Broadway, Job Corps, was introduced and welcomed to the Youth Council.

2. Review and Approval of Minutes of the January 26, 2010 Meeting

There were no questions or corrections to the minutes.

Moved/Espinosa, second/Read, to approve the minutes of the January 26, 2010 meeting.

Voice Vote: Unanimous approval.

3. Approval of Funding Extension Recommendations for the Workforce Investment Act (WIA) Youth Program for Program Year 2010- 2011

Ms. Welsch reviewed the funding recommendations for the youth program.

Staff is recommending reduced funding to Galt and discontinuing the funding of Sacramento Conservation Corps. Staff have worked with the Sacramento Conservation Corps and expected all providers to be fully enrolled in December. This is the second year that the provider has been under-enrolled and there is insufficient documentation in the case files to determine the scope and provision of services.

Unfortunately, the WIA Youth allocation has been reduced this year which required that SETA implement a 10% reduction in the proposed allocations for most programs. Ms. Welsch reviewed the allocations.

Universal services funds the youth specialists at the career centers. This funding recommendation is for \$580,000.

Board members were asked to disclose any potential conflict of interest. Mr. Brunelle stated his conflict and left the room.

Mr. Kelly stated that it is sad the level of funding has decreased from last year.

Moved/Espinosa, second/Portela, to approve the staff funding recommendations for the WIA, Title I, Youth Program, PY 2010-2011 with the program year beginning July 1, 2010. In addition, approve with the stipulations noted above and that all funding recommendations are subject to satisfactory year-end program performance reviews. Subgrantees that do not meet performance goals and benchmarks will be evaluated in August 2010 and may face deobligation of funds.

Roll Call Vote: Aye: 7, Nay: 0, Abstentions: 1 (Brunelle)

4. Review of Employer Guide by Sacramento Works for Youth and Youth Development Network - Bina Lefkovitz

Ms. Lefkovitz stated that the Youth Council funded an employer guide last year. The Youth Development Network mission is to promote youth programs and work with communities and organizations to think about how youth are served in their programs.

Mr. Brunelle stated that he really likes the way the Employer Guide is set up and thought the Employer Guide will be very helpful to the employers.

Ms. Lefkovitz asked board members to consider how to get this information out to the employer community. Ms. Welsch stated that this information has been provided to all of the youth service providers.

6. Update on Sacramento Works for Youth 2010 summer program

Ms. Julie Davis-Jaffe stated that staff have already met with the summer providers twice and have conducted training for providers to review the youth handbook. The youth team is processing eligibility and youth are getting enrolled into the program. Several providers have already filled their slots. The first payroll will begin June 6. Staff is in the process of recruiting employers for the summer program. Ms. Becky Walton passed out an employer Job Order form. Providers have a goal to place 20% of the jobs in the green jobs industry.

Ms. Welsch stated that SETA will receive TANF ECF funds to work with CalWorks families. Ms. Welsch stated that at least 1/3 of youth in our program come from TANF families; funding can be provided from this new source for the

summer program. This means that an additional 205 could be served. Almost 1,000 youth were served in last year's program.

5. Review of Youth Council goals

Ms. Welsch distributed updated youth goals. She reviewed that goals, noting that red indicated updated goals. Of the updated goals:

- Pre- and post tests has been implemented in the summer youth program.
- SETA will be implementing a virtual one stop system that will replace the SMARTware system.
- Youth Employment Guide has been completed and was presented this morning.

Ms. Lefkovitz stated that young people need to be engaged in service learning and requested that this item be agendized. There needs to be a way to connect service to academics.

7. Other business

The meeting was adjourned at 9:35 a.m.
