1	<p style="text-align: center;">Pivot Sacramento (Family Self-Sufficiency)</p> <p>Proposer requests \$43,919 to provide 90 adults who are unemployed or underemployed due to COVID-19 with case management services and a full array of CSBG resources, to help families engage in employment and training resources available through the SETA Sacramento Works America’s Job Centers of California (SWAJCC) system. Located in the Fruitridge Community Collaborative in a hub of 20 local nonprofit agencies, they are well situated to offer these services. Direct participant costs, for a wide array of support services, comprise 45% of the overall funding request, well in excess of the minimum required 15%.</p> <p>Staff recommends \$43,919 in funding for this proposal. Pivot Sacramento is well situated to provide the proposed pandemic relief services in the Fruitridge and Oak Park areas and can draw upon the 20 local nonprofit agencies with whom Pivot Sacramento shares a location.</p>
2	<p style="text-align: center;">Pivot Sacramento (Safety-Net)</p> <p>Proposer requests \$34,310 to provide 140 low-income families who have been adversely affected by the stressors affiliated with COVID-19 with food vouchers, transportation assistance, utility assistance, off-site shelter, eviction avoidance, first month rent assistance, employment supports, housing application fees, vehicle license restoration, and car repairs. Located in the Fruitridge Community Collaborative in a hub of 20 local nonprofit agencies, they are well situated to offer these services. Direct client resources comprise approximately 75% of requested funding.</p> <p>Staff does not recommend funding for this proposal due to insufficient funding available in this service category.</p>
3	<p style="text-align: center;">Folsom Cordova Community Partnership (FCCP) (Safety-Net)</p> <p>Proposer requests \$105,383 to provide 225 low-income, single-parent families with children 0-17 years of age, and unsheltered individuals/families or those at risk of becoming unsheltered, who have been adversely affected by the stressors affiliated with COVID-19, with food vouchers, utility assistance, off-site shelter, eviction avoidance, first month rent assistance, employment supports, diapers, and hygiene</p>

	<p>supplies. Direct client resources comprise approximately 76% of requested funding.</p> <p>Staff recommends \$60,000 in funding for this proposal. The proposal describes a flexible approach to providing COVID-19 relief services to its community. FCCP has a strong history of providing the proposed services in the Rancho Cordova and Folsom areas and was the only proposer with a service delivery site in that underserved area of Sacramento County.</p>
4	<p style="text-align: center;">Folsom Cordova Community Partnership (FCCP) (Family Self-Sufficiency)</p> <p>Proposer requests \$103,917 to provide 37 single parent families with children 0-5, homeless or imminently homeless families who have been adversely affected by the stressors affiliated with COVID-19, with case management services and a full array of CSBG resources, to help families more fully engage in employment and training resources available through the SETA Sacramento Works America’s Job Centers of California (SWAJCC) system, and to help these families meet their housing needs. Direct participant costs, for a wide array of support services, comprise 18% consistent with requirements of this funding category.</p> <p>Staff recommends \$103,917 in funding for this proposal. The proposal describes a flexible approach to providing COVID-19 relief services to its community through a semi-hybrid model of virtual and in-person contact with program participants. This program is proposed to be co-located at a SWAJCC, with trained staff who have a strong history of guiding hard-to-serve populations to employment and self-sufficiency.</p>
5	<p style="text-align: center;">River City Food Bank (RCFB) (Safety-Net)</p> <p>Proposer requests \$50,000 to provide 3,500 food insecure households, who have been adversely affected by the stressors affiliated with COVID-19, with nutritionally balanced 3-day supplies of food. Direct client resources comprise approximately 70% of requested funding.</p> <p>Staff recommends \$50,000 in funding for this proposal. RCFB’s service delivery system is highly efficient, brought about by leveraging labor costs with volunteers and long-term experience in the client centered distribution of nutritious foods to low income individuals and families. The agency has demonstrated flexibility in its service delivery model, which has been modified in response to COVID-19 to protect the health of staff, volunteers, and customers.</p>

<p>6</p>	<p style="text-align: center;">South County Services (SCS) (Safety-Net)</p> <p>Proposer requests \$214,536 to provide 1,500 households which have been adversely affected by the stressors affiliated with COVID-19, with food, transportation assistance, off-site shelter, eviction avoidance, first month’s rental assistance, and utility assistance and reconnection. Direct client resources comprise 28% of the requested funding, with an additional 59% of the requested funding allocated for personnel; the remaining amount was requested for office rental and related expenses.</p> <p>Staff recommends \$33,286 in funding for this proposal to fund emergency support services to low-income residents living primarily in the Galt and River Delta area, with the stipulation that a minimum of 70% of awarded funding goes to direct client resources. All other proposed staffing and services (translation services, immigration services, referral services, assistance with benefits applications, and eye exams) are considered ineligible for this funding category; they constitute non-emergency, case-managed services and activities described in the Family Self-Sufficiency 2020 CSBG CARES Act RFP funding category, for which SCS did not apply.</p>
<p>7</p>	<p style="text-align: center;">Opening Doors (Safety-Net)</p> <p>Proposer requests \$60,000 to provide 130 low-income immigrants, refugees, and survivors of human trafficking, who have been adversely affected by the stressors affiliated with COVID-19, with food, off-site shelter, first month’s rental assistance, and utility assistance and reconnection. Direct client resources comprise 70% of the requested funding.</p> <p>Staff recommends \$60,000 in funding for this proposal to fund emergency support services to immigrants, refugees, and survivors of human trafficking, in response to adverse conditions arising from the pandemic.</p>
<p>8</p>	<p style="text-align: center;">International Rescue Committee (The IRC) (Safety-Net)</p> <p>Proposer requests \$91,081 to provide 220 low-income households, which have been adversely affected by the stressors affiliated with COVID-19, with limited-time emergency assistance that includes transportation assistance, utility assistance and reconnection, eviction avoidance, and employment supports. Direct client resources comprise 67% of requested funding.</p> <p>Staff recommends \$60,000 in funding to provide emergency assistance to low-income residents of Sacramento County, with a special emphasis on refugees and</p>

	<p>other immigrants, in response to adverse conditions arising from the pandemic. This funding is recommended with the stipulation that a minimum of 70% of awarded funds be allocated to direct client resources. With 30 years of experience administering grants in Sacramento, the IRC helps thousands of low-income families each year to become resettled in the United States.</p>
9	<p style="text-align: center;">The Salvation Army (Family Self-Sufficiency)</p> <p>Proposer requests \$50,000 to provide 100 individuals, who have been adversely affected by the stressors affiliated with COVID-19, with training in the proposer’s Culinary Arts Training Program and Construction Training Program. Direct participant costs, for a wide array of support services, comprise 80% consistent with requirements of this funding category.</p> <p>Staff does not recommend funding for this program due to the lack of available funds.</p>
10	<p style="text-align: center;">The Salvation Army (TSA) (Safety-Net)</p> <p>Proposer requests \$106,250 to provide 425 families, who have been adversely affected by the stressors affiliated with COVID-19, with utility assistance, off-site shelter, eviction avoidance, and first month rental assistance at TSA’s Family Services’ eight (8) sites and collaborative partner locations throughout Sacramento County, including North Sacramento, North Highlands, Urban League, downtown Sacramento, Oak Park, Citrus Heights, Florin and Arden Arcade. Direct client resources comprise 80% of the requested funding.</p> <p>Staff recommends \$60,000 in funding for this proposal. The Salvation Army has a long history of providing the proposed services to low-income residents of Sacramento County. They are well-positioned to provide emergency support services in many areas of the County in response to adverse conditions arising from the pandemic.</p>

Direct participant costs for employment support services comprise 10.7% of this request.</p> <p>Staff recommends \$78,042 in funding for this proposal with the stipulation that</p>

	<p>Wind Youth Services budget the minimum level of direct participant services required under this 2020 CARES Act CSBG RFP category of 15% of the recommended award. Wind Youth Services has a long history of providing direct services and counseling resources for homeless, imminently homeless, and runaway youth in Sacramento County.</p>

(Wind) (Safety-Net)</p> <p>Proposer requests \$31,000 to provide 250 homeless and imminently homeless youth, who have been adversely affected by the stressors affiliated with COVID-19, with food, transportation, utility assistance and reconnection, vehicle assistance and repair, and first month rent assistance. Direct client resources comprise 100% of requested funding.</p> <p>Staff recommends \$24,800 in funding for this proposal. Wind has a long history of providing services for Sacramento County’s homeless and imminently homeless youth, and is well positioned to provide emergency support services to youth who are experiencing adverse effects of the pandemic.</p>
13	<p style="text-align: center;">Volunteers of America (Safety-Net)</p> <p>Proposer requests \$60,000 to provide 215 homeless and very low-income veteran, National Guard, and reservist households and their families, who have been adversely affected by the stressors affiliated with COVID-19, with food, utility assistance and reconnection, off-site emergency shelter, eviction avoidance, first month rent assistance, and transportation assistance. Direct client resources comprise 100% of requested funding.</p> <p>Staff recommends \$54,000 in funding for this proposal, with the stipulation that eligibility for CSBG services be determined by SETA’s CSBG standards instead of the “30% of Area Median Income” standard noted in the proposal. VOA’s proposed service delivery system is leveraged through collaboration with program partners, allowing all CSBG resources proposed to directly assist veterans, reservists and National Guard servicemembers and their families in need as a response to the adverse impacts of COVID-19.</p>

	<p>resources are not listed in the requested funding, although a minimum of 15% of proposed funding is a required allocation for this program type.</p> <p>Staff recommends \$65,008 in funding for this proposal, with the stipulation that a minimum of 15% of awarded funding be allocated for direct client resources. The proposed program is a direct response to an academic support need resulting from the challenges of educating children while sheltering in place. SJPRC has a long history of working with homeless children and parents by providing them stability, structure, and exposure to growth opportunities.</p>
15	<p style="text-align: center;">World Relief Sacramento (Family Self-Sufficiency)</p> <p>Proposer requests \$78,506 to provide 72 individuals who have been adversely affected by the impact of COVID-19 with case management services and a full array of CSBG support service resources to help families more fully engage in employment and training resources available through the SETA Sacramento Works America's Job Centers of California (SWAJCC) system. Direct client resources comprise 19% of requested funding.</p> <p>Staff recommends \$78,506 in funding for this proposal. The proposal focuses on employment services for low-income, vulnerable families, who have been hardest-hit by the pandemic and are experiencing unemployment and underemployment.</p>

Direct client resources comprise 77% of requested funding.</p> <p>Staff recommends \$37,724 in funding for this proposal from CARES Act Discretionary funding. The proposal focuses on emergency support services for low-income, vulnerable families, including refugees, recent immigrants, minority populations, and families with children 0-5 years of age, who have been particularly hard-hit by conditions resulting from the pandemic.</p>
17	<p style="text-align: center;">Elk Grove Adult and Community Education (EGACE) (Family Self-Sufficiency)</p> <p>Proposer requests \$63,014 to provide 36 single-parent, justice-involved, and homeless households and who have been adversely affected by the stressors affiliated with</p>

	<p>COVID-19, with case management services and a full array of CSBG support service resources to help families more fully engage in employment and training resources available through the SETA Sacramento Works America’s Job Centers of California (SWAJCC) system. Direct client resources comprise 45% of requested funding.</p> <p>Staff recommends \$63,014 in funding for this proposal. This program envisions co-location at a SWAJCC and provision of support and employment services to low-income, vulnerable households who have been most affected by COVID-19.</p>
18	<p style="text-align: center;">Elk Grove Adult and Community Education (EGACE) (Safety-Net)</p> <p>Proposer requests \$44,906 to provide 177 underserved minority, single-parent, low-income or homeless households who have been adversely affected by the stressors affiliated with COVID-19, in the Florin, Lemon Hill, and Elk Grove zip codes with emergency supports including food vouchers, transportation vouchers, utility assistance/reconnection, personal protective equipment, internet bill assistance, and eviction avoidance. Direct client resources comprise 72% of requested funding.</p> <p>Staff recommends \$44,906 in funding for this proposal. This program proposes to provide emergency support services to several target areas and populations whose limited financial situations are further complicated by the effects of COVID-19.</p>

(LFCD) (Family Self-Sufficiency)</p> <p>Proposer requests \$125,000 to provide 75 low-income, single-parent families, domestic violence survivors, immigrants, individuals experiencing homelessness or imminent homelessness, and/or individuals with disabilities, who have been adversely affected by the stressors affiliated with COVID-19, with emergency support services through intensive case management and linkages to responsive services. In addition, LFCD will collaborate with Sacramento Works America’s Job Centers of California in preparation for career planning, job readiness and life skills workshops and occupational training. Direct client resources comprise 15% of the funding request.</p> <p>Staff recommends \$125,000 in funding for this proposal. The proposal identified multiple economic concerns expressed by their customers which have arisen as a result of COVID-19, and Lao Family proposes to assist these families with employment while providing emergency support services to mitigate barriers to success. Lao Family has a successful history of providing employment and supportive services to SETA target groups, countywide.</p>

	<p>households, who have been adversely affected by the impact of COVID-19, with a resource center and staff who address the emergency support needs in the areas of food, utilities assistance, off-site shelter, eviction avoidance, and first month's rental assistance. The proposal envisions the center as a community hub which provides a digital learning hub, family support services, meals to go, and educational workshops.</p> <p>Staff does not recommend funding for this proposal. Family Self-Sufficiency funding through SETA's CSBG program is based upon a case management model, with emergency support services to assist participants towards their goal of self-sufficiency. Funding of a community center is not part of the allowable activities for this category.</p>
21	<p style="text-align: center;">Rose Family Creative Empowerment Center (Rose Family) (Safety-Net)</p> <p>Proposer requests \$86,068 to provide 200 low-income African-American single-parent households, who have been adversely affected by the impact of COVID-19, with utility assistance, off-site shelter, eviction avoidance and first month's rental assistance. Direct client resources comprise 38% of requested funding.</p> <p>Staff recommends \$33,286 in funding for this proposal, with the stipulation that a minimum of 70% of awarded funds be allocated for direct participant costs. Rose Family is well positioned in the South Sacramento community to provide emergency supports to African American families who are encountering the adverse economic impacts of COVID-19.</p>
22	<p style="text-align: center;">The Salvation Army (Family Self-Sufficiency)</p> <p>Proposer requests \$56,250 for 72 low-income youth enrolled in grades K-8, who have been adversely affected by the impact of COVID-19, to be enrolled in Elev8, a licensed after-school program with behavioral, educational, and recreational guidance, and a structured curriculum. Direct client resources comprise 87% of requested funding.</p> <p>Staff does not recommend funding for this proposal. Family Self-Sufficiency funding through SETA's CSBG program is based upon a case management model, with emergency support services to assist participants towards their goal of self-sufficiency in response to a COVID-19 environment. This after-school program had no description of a case-management model, and made no accommodation for the pandemic environment.</p>

These constraints are particularly challenging for unsheltered individuals and families, since common gathering areas have been shuttered to prevent the spread of the virus. The current proposal offers solutions to these challenges. Direct client resources comprise 8% of requested funding.</p> <p>Staff recommends \$60,164 in funding for this proposal, with the stipulation that 15% of the funding be allocated for direct client support services. The proposed program is designed as a direct response to employment needs of homeless individuals in a COVID-19 environment. Sacramento Self-Help Housing has many years of experience in successfully working with the homeless population of Sacramento County.</p>

Direct client resources comprise 74% of requested funding.</p> <p>Staff recommends \$60,000 in funding for this proposal. Mutual Assistance Network has an established reputation for quality service delivery in these communities, and is well positioned to provide emergency support services to households affected by the adverse economic impacts of COVID-19.</p>
26	<p style="text-align: center;">My Sister’s House (Safety-Net)</p> <p>Proposer requests \$44,328 to provide 85 predominantly Asian/Pacific Islander, low-income and homeless survivors of domestic violence, who have been adversely affected by the impact of COVID-19, with utility assistance and reconnection, eviction avoidance, and first month rent assistance. Direct client resources comprise 85% of requested funding.</p> <p>Staff does not recommend funding for this program due to insufficient funding remaining in this category.</p>

Fresh produce and protein have been a particular need during these times, and it is necessary to purchase these items to ensure that a healthy array of food is available. In addition, the proposer wants to expand the existing utility assistance program to help people in zip codes outside of the current program which is limited to City of Elk Grove residents. Direct client resources comprise 73% of requested funding.</p> <p>Staff recommends \$54,000 in funding for this proposal. EGFBS is the only food bank serving Elk Grove and the surrounding areas, and provides a wide array of safety-net and self-sufficiency related services to homeless and low-income households of Sacramento County. The proposed utilities assistance program will provide further help to families in need in the South Sacramento County area. EGFBS has consistently met SETA contract goals in the past.</p>
