## PUBLIC NOTICE – Release of Request for Proposals – Street Outreach Services

The Sacramento Safe Community Partnership (SSCP) is a partnership among the Governor's Office of Gang and Youth Violence Policy, the City of Sacramento Police Department, the Sacramento Employment and Training Agency (SETA), Area Congregations Together and faith and community-based organizations. The goal of this initiative is help make the Sacramento community safer while providing young people at risk of violence with a real opportunity to turn their lives around.

The strategy developed by SSCP focuses on five building blocks for success:

1. **Data Analysis**
2. **Direct Communication**
3. **Support Services Pipeline**
4. **Community Outreach**
5. **Coordination of Law Enforcement Efforts**

The Sacramento Safe Community Partnership will monitor and fine-tune the strategy by tracking all aspects of the program, including crime statistics of targeted individuals and areas, quantities and types of social services provided, and recidivism rates for those who receive services. The Partnership will adjust the strategies and services provided to ensure that the specific needs of individual communities are met.

The Sacramento Employment and Training Agency (SETA) has assumed the responsibility to deliver and/or procure the services required for Steps 3 (Support Services Pipeline) and 4 (Community Outreach). The Sacramento Employment and Training Agency (SETA) is releasing a **Request for Proposals (RFP) for Street Outreach** services (Community Outreach) under the Sacramento Safe Community Partnership funding. **This RFP is limited to Street Outreach services.** Responses to this RFP process will be considered for the program funding cycle beginning July 1, 2011.

The Request for Proposals will be released on Friday, April 8, 2011. Interested parties are encouraged to apply.
