# APPROVAL OF SOLE SOURCE FINDING FOR SELECTION OF ONE-STOP OPERATOR AND FORWARD TO THE SETA GOVERNING BOARD WITH REQUEST FOR AGREEMENT

#### BACKGROUND:

The Workforce Innovation and Opportunity Act (WIOA) and the regulations implementing the Act require the Workforce Development Board (WDB), in concurrence with the Governing Board, to select a One Stop Operator to operate the "America's Job Center of California" system as the mechanism for delivering WIOA services within the Sacramento Workforce Development Area.

The regulations require this selection process be performed by a competitive procurement process.

At your January 27, 2021 Board meeting you approved the recommendation of the Executive Committee to award the procurement to SETA. Your approval did not include a sole source finding. On review it was determined that it should have included such a finding. To cure this Legal Counsel proposes to read the following sole source finding into the record:

The Board finds that, after solicitation of a number of sources and public advertising of the opportunity to submit proposals, competition has been deemed inadequate after issuance of the RFQ. While two organizations expressed interest in submitting proposals to serve as the One Stop Operator, SETA was the only organization that submitted a proposal. Consistent with Federal WIOA Regulations and the OMB Uniform Guidance (2 CFR 200.320), non-competitive procurement is appropriate under these circumstances.

#### RECOMMENDATION:

Adopt Legal Counsel's sole source finding for the selection of SETA as the One-Stop Operator then forward the matter to the SETA Governing Board with a request for its agreement.
