They hired a young person from our program. It was a good fit for Mr. Hoke since the employer is a supporter of the program. The interview went very well. Mr. Walker stated that he has confirmed an interview with Grocery Outlet; Mr. Ron Orr will participate in this interview. Mr. Baker stated we started the year with a blank slate and it looks great to have a full schedule.
- E. Survey Response & Data Update: Mr. Baker reported that the survey went out to employers with whom we have a long-standing relationship plus some employers we have worked with in the last 12 months.

A "New Employer" survey has been developed to encourage employers that have no relationship with Sacramento Works Employer Services to use our services. Once we get the employer responses, they will move to our e-mail list

to be engaged with our E-Newsletter communications. Mr. Walker reported that we have nine survey responses from employers who have used our services. The results indicate that 100% of the employers responding are looking for staff; of that, most are in 'other' industries (manufacturing, government, transportation and trade), and 33% are large employers.
