West El Camino, East Bidwell, and Arden Arcade were all closed, probably due to Rite Aid and CVS locating nearby. Mr. William Walker reported that Liquibox is closing their facility. Kaiser issued a state-wide notice that they are laying off 102 people, mostly IT and management.

Mr. Nottoli inquired about the Nestlé Water closure. Mr. Walker reported that they closed their distribution center for frozen food; all of the frozen food is coming from the mid-West; they are centralizing their distribution.

Kaiser pharmacy is laying off senior management in a couple of local pharmacies.

ITEM II-D - CONSENT

APPROVAL TO ADD OK TRAINING PROGRAM TO SETA'S VENDOR SERVICES (VS) LIST

BACKGROUND

On December 5, 2005, the SETA Governing Board approved the release of the Vendor Services (VS) Request for Qualifications (RFQ) to recruit qualified vendors on an ongoing basis to provide services to eligible adults and youth in an effort to prepare them for participation in the labor force and to expand SETA's VS List. Since that time, the SETA Governing Board has approved several amended releases of the RFQ to expand the selection of Adult and Youth Workforce Development Services and Child Development (ages 0-5) and Family Services. Vendor services are fee-for-service activities that provide additional options for adults and youth who face challenges to academic success and/or gainful employment, as well as supportive services for Child Development and Family Services.

All vendors recommended for inclusion on SETA's VS List have demonstrated that the services proposed are justified and align with the Sacramento Works America's Job Centers of California (SWAJCC) system, as well as Children and Family Services.

OK Training Program submitted an application in response to SETA's VS List RFQ to offer In-Service Training. After evaluating the application, SETA has determined that OK Training Program effectively demonstrated its ability to provide the proposed service.

OK Training Program, LLC is a small two-member consultancy formed in April of 2019. Their stated purpose includes capacity building for staff working at government-related agencies, such as the America's Job Centers of California, non-profits organizations, Community Colleges, and other organizations that benefit from basic and advanced workforce development strategies. The overall objective of their curriculum is for service providers to obtain skills and strategies that will result in increased job placement and retention outcomes.

As an approved vendor, OK Training Program will provide In-Service Training for the professional development of SETA and program partner staff with the goal of improving and enhancing job readiness training, and increasing job placement and retention outcomes for disadvantaged, at-risk youth and adults.

<u>ITEM II-E - CONSENT</u>

APPROVAL TO MODIFY PEOPLE WORKING TOGETHER (PWT) UNITED'S VENDOR SERVICES CONTRACT

BACKGROUND:

In 2018, the SETA Governing Board approved People Working Together (PWT) UNITED for SETA's Vendor Services (VS) List offering Job Readiness/Pre-Employment Skills Training to provide pre-apprenticeship training to SWAJCC system customers.

In order to help better prepare students for the physical demands of construction and increase their job readiness, PWT United submitted a formal request to modify its VS contract to increase its hours and fees. A team comprised of program and contracting staff reviewed and evaluated PWT United's request and determined that the request is justified and that the new proposed fees are reasonable in cost.

Staff is seeking approval of the attached recommendation for modification.

Applicant's Background:

PWT United Inc. was established in 2015 as a non-profit, community-based organization to provide training that prepares adult men and women for entry into various construction trades' apprenticeship programs. PWT United currently provides a six-week (120 hour) pre-apprenticeship training program that utilizes the Multi-Craft Core Curriculum (MC3), which was developed by North America's Building Trades Union (NABTU).

In order to prepare the students for the physical demands of construction, PWT proposed to add a health and awareness component to their existing job-readiness training, to be facilitated by a certified instructor twice a week for a total of an additional 15 hours. PWT also proposed adding an additional 15 hours of classroom instruction to cover preparation for both Fork Lift Certification and for the Armed Services Vocational Aptitude Battery (ASVAB Test). The ASVAB Test is utilized by certain skilled craft trades for entry into their apprenticeships. These components will enable students to demonstrate job readiness for acceptance into their desired trade. Adding these components to the current curriculum will increase the hours by another 30 hours and the cost accordingly.

PWT United's target participants will be comprised of those who live in underserved communities, graduated from under achieving high schools/continuation schools, and ex-offenders. Approval of the proposed rate increases will ensure PWT's ability to continue meeting the needs of SWAJCC system customers who are seeking to increase their employability and pursue a career in the construction trades.

ITEM III-A – 3 - ACTION

TIMED ITEM 10:00 A.M. AND PUBLIC HEARING: APPROVAL OF REVISIONS TO THE SALARY SCHEDULES FOR ASSOCIATE TEACHER TIER I, ASSOCIATE TEACHER TIER II, ASSOCIATE TEACHER TIER III, HEAD START COOK/DRIVER, HEAD START FAMILY PLACEMENT WORKER, HEAD START TEACHER ONE, HEAD START TYPIST CLERK II, AND TYPIST CLERK II

BACKGROUND:

This agenda item provides the opportunity for the Governing Board to approve revisions to eight (8) job classifications to align with new minimum wage rates that became effective January 1, 2017. New legislation (SB3) was signed into law on April 4, 2016, raising California's minimum wage to \$15.00 per hour effective January 1, 2022. The law requires increases to the minimum wage in a series of steps:

- 1. On January 1, 2017, the minimum wage increased to \$10.50 per hour.
- 2. On January 1, 2018, the minimum wage increased to \$11.00 per hour.
- 3. On January 1, 2019, the minimum wage increased to \$12.00 per hour.
- 4. On January 1, 2020, the minimum wage will increase to \$13.00 per hour.
- 5. On January 1, 2021, the minimum wage will increase to \$14.00 per hour.
- 6. On January 1, 2022, the minimum wage will increase to \$15.00 per hour.

Compliance with the law will require revisions to eight (8) Agency job classifications including: Associate Teacher Tier I, Associate Teacher Tier II, Associate Teacher Tier III, Head Start Cook/Driver, Head Start Family Placement Worker, Head Start Teacher One, Head Start Typist Clerk II, and Typist Clerk II. The Policy Council and SETA Governing Board previously took action to adjust 2017, 2018, and 2019 rates. Below are the classifications that are affected by the minimum wage increase.

APPROVAL TO SUBMIT AN APPLICATION TO THE EMPLOYMENT DEVELOPMENT
DEPARTMENT (EDD) FOR WORKFORCE INNOVATION AND OPPORTUNITY ACT
(WIOA) FUNDS FOR A VETERANS EMPLOYMENT-RELATED ASSISTANCE
PROGRAM AND AUTHORIZE THE EXECUTIVE DIRECTOR TO EXECUTE THE
AGREEMENT AND ANY OTHER DOCUMENTS REQUIRED BY THE FUNDING
SOURCE

BACKGROUND:

The Employment Development Department in coordination with the California Workforce Development Board and the California Labor and Workforce Development Agency announced the availability of funds for Veterans Employment-Related Assistance (VEAP) programs. The goal of this initiative is to promote the use of industry sector strategies as the framework for addressing the need of veterans to transition to high-wage, high-growth occupations using their skill sets obtained in the military. Staff is requesting approval to submit a proposal to work with the Sacramento Valley Manufacturing Initiative (SVMI), Folsom Cordova Adult Education and other significant regional partners to recruit, assess, interview, select and train eligible veterans and/or their spouses for employment in the manufacturing/energy/utility cluster.

SETA has been awarded previous VEAP grants by EDD, which trained utility line worker trainees. The primary focus of this program places an emphasis on the recruitment of recently separated veterans and/or their spouses, providing intensive case management along with Post-Traumatic Stress Disorder (PTSD) assessment as needed.

SETA is developing a new Proposal for 2019-2020 to focus on the manufacturing/energy/utility cluster, specifically to meet the growing need for Welders in the region. SETA will provide the staff and facilities required to provide orientation, assessment, pre-screening, and interviewing to select veterans and/or their spouses to enroll in the VEAP Program and provide case management, supportive services, and follow-up and retention services for participants while they participate in the training with the goal of 100% completion. For this proposal, SETA will continue to collaborate with the other regional veteran programs, such as Volunteers of America for intensive case management services and PTSD counseling. SETA is requesting an award of \$500,000 to serve 60 veterans and/or spouses. The submission deadline for the application is December 6, 2019.

RECOMMENDATION:

Approve the submission of the Veterans Employment Assistance Program application to the California Employment Development Department requesting \$500,000 to provide services to 60 veterans and/or spouses. Authorize the SETA Executive Director to execute the agreements, modifications and any other documents required by the funding sources.

ITEM III-B - 2- ACTION

APPROVAL OF COMMUNITY SERVICES BLOCK GRANT (CSBG) FUNDING RECOMMENDATIONS FOR PROGRAM YEAR 2020

BACKGROUND:

On August 2, 2019, SETA released a Request for Proposals (RFP) for the CSBG program for program year 2020. The RFP solicited services under the Safety-Net, Youth and Senior Support, and Family Self-Sufficiency categories as identified in the 2020-2021 CSBG Community Action Plan. The amount of funding available for program services was estimated to be \$845,000, of which 39% was allocated to Safety-Net or short-term emergency services, 39% allocated to case-managed Family Self-Sufficiency services, and 22% allocated to Youth and Senior Support services.

The RFP included a special project to prevent or eliminate recidivism of felony or misdemeanor arrests in Sacramento County among African American youth 14-17. The successful proposals were eligible to receive up to \$40,000 under this service category. Success measures under this service area will include the number of project participants without a recidivating event during 180 days of project participation.

The deadline for receipt of proposals was September 12, 2019. Thirty-two (32) proposals were received by the 5:00 p.m. deadline, requesting a total of \$1,284,901. All thirty-two (32) proposals were evaluated. One additional proposal was submitted by email after the 5:00 p.m. deadline and was not evaluated, per the RFP instructions.

Evaluation Process:

All proposals received through this solicitation went through a comprehensive review process to provide funding recommendations to the Community Action Board. Staff recommendations were developed through the deliberations of a team of ten (10) readers representing SETA's Workforce Development and Fiscal Departments, Contracts unit, and Head Start Department, in addition to one member from the Department of Human Assistance. The readers evaluated, scored and ranked each proposal using standardized evaluation and scoring criteria that were identified in the RFP. Proposals were scored and ranked into four categories based on their numerical score.

The top ranked proposals achieved their scores based on the following criteria:

- ➤ The proposing agency had a history of successfully operating the proposed program or a similar program, had sufficient leveraged funding, and demonstrated the establishment of collaborative partnerships.
- ➤ The proposing agency adhered to the service priorities set forth in SETA's 2020-2021 Community Action Plan.

➤ The proposing agency succeeded in achieving planned, contracted goals; or, if not previously funded by CSBG, the agency demonstrated a potential for success.

- > The proposing agency demonstrated a need exists for the service.
- ➤ If applying for the Family Self-Sufficiency category, the proposing agency had a clear description of a case-management system and had a connection with the system of Sacramento Works America's Job Centers.

Staff also considered that all identified high-risk and underserved neighborhoods would have access to services and ensured that all identified target groups would be served. Due to limited availability of CSBG funding, only twenty-two proposals are being recommended for funding.

Three new agencies, Rose Family Creative Empowerment, Women's Empowerment, and Elk Grove Adult & Continuing Education are recommended for funding.

The 11 successful Safety-Net proposals are recommended with the stipulation that at least 70% of awarded funding be allocated for direct participant support services. As required in the RFP, Family Self-Sufficiency proposals are required to allocate a minimum of 15% of the awarded funding for direct participant support services.

All funding recommendations are made contingent upon successful agency status and performance by the end of calendar year 2019.

Attached are the resulting proposal rankings and staff funding recommendations. Proposal summaries and funding rationale will be submitted under separate cover. The Community Action Board (CAB) approved funding recommendations at its November 13, 2019 meeting.

RECOMMENDATION:

Approve staff funding recommendations for the Program Year 2020 Community Services Block Grant.

The unemployment rate in the Sacramento--Roseville--Arden-Arcade MSA was 3.1 percent in October 2019, up from a revised 3.0 percent in September 2019, and below the year-ago estimate of 3.5 percent. This compares with an unadjusted unemployment rate of 3.7 percent for California and 3.3 percent for the nation during the same period. The unemployment rate was 3.0 percent in El Dorado County, 2.8 percent in Placer County, 3.2 percent in Sacramento County, and 3.2 percent in Yolo County.

Between September 2019 and October 2019, combined employment in the counties of El Dorado, Placer, Sacramento, and Yolo, increased by 3,500 to total 1,033,600 jobs.

- Government (up 5,800 jobs) led the region with a normal seasonal job gain from September to October. State government (up 3,000 jobs) and local government (up 2,800 jobs) experienced seasonal gains in education as schools were back in session. Federal government was unchanged.
- Education and health services expanded by 1,700 jobs. Health care and social assistance accounted for 70.6 percent of the expansion, picking up 1,200 jobs. Educational services added 500 jobs.
- Financial activities advanced by 700 jobs over the month. Finance and insurance grew by 600 jobs. Real estate and rental and leasing was up 100 jobs.
- Meanwhile, five major industries reported month-over decline, led by construction (down 2,900 jobs), leisure and hospitality (down 1,700 jobs), and farm (down 1,000 jobs).

Between October 2018 and October 2019, total jobs in the region increased by 15,100, or 1.5 percent.

- Education and health services continued to lead year-over growth, adding 6,600 jobs.
 Health care and social assistance led the expansion with 6,200 jobs. Educational services added 400 jobs.
- Construction gained 4,600 jobs since last October. Specialty trade contractors (up 3,500 jobs) was responsible for 76.1 percent of the job gains.
- Trade, transportation, and utilities advanced by 2,000 jobs. Transportation, warehousing, and utilities (up 2,300 jobs) was responsible for a majority of the year-over growth.
 Wholesale trade gained 600 jobs. These gains offset a decline in retail trade, which shed 900 jobs.
- Three major industries experienced job reductions from last October. Government was down 2,100 jobs. Information shed 600 jobs. Other services cut back 400 jobs.

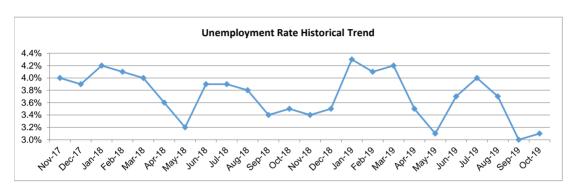

Program Information Report (PIR) Overview

Background and Purpose.

In 1978, the national Head Start Bureau (aka OHS) began the first uniform collection of Head Start program data to describe the nation's program. By the mid-1980s, the Head Start Program Information Report, commonly referred to as the "PIR," was the "principal source of basic information about the operating characteristics of Head Start programs and the services they provide" (Ellsworth 1978). The PIR is an extensive survey that all Head Start and Early Head Start programs are required to complete on an annual basis. Data collected through the PIR is used for a variety of purposes:

- to describe varied program design and staffing patterns
- to report funded and actual enrollment levels
- to describe and quantify the services delivered by each program, and
- to identify demographic and social trends among the children and families served.

The PIR also provides summary data at the national, regional, state, city and zip code levels. Selected areas of the reports are used to inform national policy decisions and provide timely information in response to Congressional and public inquiries about the program.

2018-2019 PIR Reports.

There are three charts attached - one Head Start chart which represents services to preschool aged children and two Early Head Start charts which represent services to infants, toddlers and pregnant woman. These summary charts are not inclusive of all questions included in the PIR but instead focus on key indicators for program quality and threshold comparisons.

Summary of Results and Corrective Plans.

- Overall, Sacramento County Head Start and Early Head Start programs performed on par with previous years.
- Sacramento County tends to show higher enrollment turnover in the first 45 days than its national, regional and state counterparts.
- Nearly all enrolled children have an identified medical home and medical insurance.
- The percentage of children completing all medical screenings has declined from last year and falls below national, regional, and state averages.
 - To count as medically complete, a child must be up-to-date on ALL of the following screenings: hearing, vision, blood pressure, height/weight, physical exam, blood lead, and TB.

- Data analysis showed that 836 out of 2,683 children were missing a Blood Lead Screening provided by their primary physician. This represents 23% of all grantee enrolled children during the program year. Delegate agencies largely reported the same trends.
- In 2019-2020, the grantee will work collaboratively with its delegate agencies, partners, regional office staff, the public health office, and the Health Services Advisory Committee to develop strategies:
 - to address missing Blood Lead Screenings (BLS);
 - to partner with local medical providers to complete age-required BLS as an important element of wellness for young children and in accordance with the pediatric periodicity table, Bright Futures;
 - to educate parents on the importance of advocating for a BLS;
 - to explore/develop partnerships with local medical providers to perform on-site BLS for children as needed.
- 97% of children received follow-up medical treatment as needed. This is higher than SETA's national, regional and state counterparts.
- The percentage of children completing a dental examination has slightly declined from last year and is slightly lower than regional and state counterparts, but on par nationally.
 - o In 2019-2020, the grantee will work collaboratively with its delegate agencies, partners, and dental consultants to develop strategies:
 - to re-visit center locations where absent children may have missed the original dental visit;
 - to increase parent education on the importance of dental hygiene and annual dental examinations;
 - to seek formal partnerships with public dental van agencies to increase on-site dental examinations where results tend to be lower.
- Staff have assisted more than 190 families experiencing homelessness during the program year.
- 192 enrolled children were in foster care at some point during the program year, representing 2.6% of the total cumulative enrollment for the year.
- Nearly 82% of all Head Start teachers hold a Bachelor's degree or higher, outpacing national, regional and state counterparts.

This Information Memorandum (IM) is to inform grantees of a simplified accounting procedure that will go into effect beginning in fiscal year (FY) 2020. Currently, the Office of Head Start's (OHS) accounting structure includes two separate Common

Accounting Numbers (CANs) for Head Start and Early Head Start operations. OHS will streamline the current structure by transitioning to the use of a single CAN for operations, inclusive of both Head Start and Early Head Start service funds. This change is meant to lessen administrative burdens grantees face when operating both programs. These CANs are known as Program Accounts 4122 and 4125 for Head Start and Early Head Start, respectively.

Starting in FY2020, all Head Start and Early Head Start operations amounts will be funded from CAN 4122. This change does not affect Program Accounts 4120 and 4121, the Head Start and Early Head Start training and technical assistance (T/TA)

CANs, due to statutory requirements placed on those funds. This change only applies to traditional Head Start and Early Head Start grants and has no impact on Early Head Start-Child Care Partnership/Early Head Start Expansion grants. Furthermore, this accounting change does not affect annual funding and enrollment levels for Head Start or Early Head Start and does not change the processes for programs seeking to convert slots.

This accounting structure change has no impact on how a grantee will continue to submit program-level funding requests or requests for conversion of slots, nor will it have an impact on the underenrollment process. Funding guidance letters will continue to be provided with annual funding and enrollment levels for Head Start and Early Head Start along with instructions on how grantees will apply for funding.

Deputy Director, HS Manager and Health/Oral Health Partners <u>Speak to UC Davis Students</u>

On October 30th, Deputy Director/Denise Lee, Manager/Lisa Carr, and partners from Access Dental Plan/Martha Cisneros Campos and the Center for Oral Health/Early Smiles Sacramento/Mira Yang RDH spoke to UC Davis under-graduate and graduate students. The purpose of the panel presentation was to introduce students to the Head Start/Early Head Start program and share information and data about health and oral health

issues for children and families in poverty.

ITEM V - REPORTS TO THE BOARD

A. <u>CHAIR'S REPORT</u>: The Chair of the SETA Governing Board, on a regular basis, receives numerous items of information concerning employment and training legislation, current programs, agency activities, and miscellaneous articles about human service programs throughout the nation, and attends meetings pertinent to SETA business.

The important information from the material received and meetings attended will be shared with the entire Board and the method proposed by the Chair is to give a verbal report at each regular meeting. It will also allow time for the Board to provide input on items that may require future action.

B. <u>EXECUTIVE DIRECTOR'S REPORT</u>: This item is set aside to allow the SETA Executive Director to report to the Board on any items of important information or to deal with special requests which need to be addressed but, because of time constraints, were not included in the formal SETA Governing Board Packet.

The Executive Director's Report also allows the opportunity for the SETA Executive Director to apprise the Board of upcoming events, significant agency activities, or conferences.

- C. <u>DEPUTY DIRECTORS REPORT:</u> This item is set aside to allow the Deputy Directors to report to the Board any items relative to the program operations.
- D. <u>COUNSEL REPORT</u>: The SETA Legal Counsel is the firm of Gregory D. Thatch, Attorney at Law. This item provides the opportunity for Agency Counsel to provide the SETA Governing Board with an oral or written report on legal activities
- E. <u>MEMBERS OF THE BOARD</u>: This item provides the opportunity for SETA Governing Board members to raise any items for consideration not covered under the formal agenda. It also provides the opportunity for Board members to request or to ask that certain items be placed on the next Governing Board agenda.
- F. <u>PUBLIC PARTICIPATION</u>: Participation of the general public at SETA Governing Board meetings is encouraged. The SETA Governing Board has decided to incorporate participants of the audience as part of its agenda for all meetings. Members of the audience are asked to address their requests to the Chairperson, if they wish to speak.
