1. <u>Call to Order/Roll Call:</u> Mr. Gordon called the meeting to order at 3:33 p.m. The roll was called and a quorum was achieved.

Youth Committee Members and staff toured the Asian Resources, Inc. (ARI) facility.

Mr. Perez arrived and was seated at 3:45 p.m.

2. <u>Consent:</u> Approval of Minutes of the July 13, 2023, Special Youth Committee Meeting

Moved/Stephens, second/Hutchinson, to approve the minutes of the July 13, 2023 Special Youth Committee Meeting

4. <u>Information:</u> Youth Voice Training Update and Recruitment Efforts Mr. Rocha-Rosario and Ms. Medina introduced themselves and provided updates on youth voice recruitment, meetings, training, and projects.

The flyer that the Youth Voice Sub-Committee is working on was provided in the packet. The following changes to the flyer were suggested: color scheme (colored copies vs. black and white), formatting (clip art), provider names and

contact information to be included on the flyer, QR code, and functions. Mr. Rocha-Rosario advised that once the flyer gets re-vamped, it will be provided to all of the Sacramento Works providers.

Ms. Baloyos advised that generic flyers are more advantageous than flyers for one specific location in recruitment efforts. Mr. Stephens suggested making the flyer's image more relevant to youth. Mr. Gordon said having a more significant title would attract more clients. He wondered if it's possible to get media time donations to promote this public service. Ms. Mechals stated that she would connect with Uptown Studios on more media awareness.

3. <u>Information:</u> Asian Resources Inc. – Tour and Program Highlights Isela Peña, Senior Employment Service Specialist, and Lindsey Thao, Senior Youth Employment Service Specialist, via Zoom, presented program highlights and provided program flyers.

The overview covered the following programs:

- Out-of-school youth (paid work experience program for youth 18-24). The
 program includes paid work experience, employment support services, GED
 preparation, transportation assistance, case management, life skills
 development, and academic and career exploration.
- Need help finding a job? The program includes writing a cover letter, resume assistance, job search, mock interview, career guidance, on-the-job training, resources, and referrals.
- Interview preparation (1-on-1 coaching). The program includes building selfconfidence, mastering elevator pitches, mock interviews, negotiating salary, networking, and more.
- On-the-job training program (employer program)
- English as a second language program

Mr. Stephens asked what are the current interest trends among the youth. Ms. Lindsey advised that last year, cashier and other basic positions were of interest to the youth, and medical and administrative jobs and training are in demand. Ms. Vega stated that different youth have different interests.

Ms. Vega advised that she and Ms. Thao each have 13 enrollment spots for the Out-of-school program, which is on a first-come, first-served basis. ARI pays for up to 240 hours, and that's what limits the enrollment to 26 spots. Even if the out-of-school program is full or if youth do not qualify, interested youth are referred to ARI's adult program. Ms. Thao noticed an increase in the number of youth with disabilities or language barriers interested in the program this year.

Mr. Caditz left the meeting at 4:12 p.m.

Ms. Baloyos reviewed the Executive Academy program highlights. The flyer was provided. This nine-month program is for low-income, immigrants, refugees, or

youth of color aged 16-24. The program contains two phases. During Phase 1, the youth receive training in the following areas: unleash your Brain Power, improve decision-making, social-emotional intelligence, financial management, public relations, work ethics, career exploration, individual coaching, and paid work experience. The second phase includes 1-on-1 coaching and graduation from the program. There were 32 participants in Phase 1 this year.

Ms. Stephens was interested in what barriers ARI had to overcome to prepare participants for employment and training. Ms. Baloyos stated that ARI addresses language barriers, child care, access to information, and transportation struggles that may hinder participants from getting employed.

- 5. **Public Input:** Mr. Kim advised that the last date for the current SETA Executive Director will be Friday, September 15, 2023. The new Interim Executive Director is D'et Saurbourne, starting Monday, September 18, 2023.
- 6. **Adjournment:** The meeting was adjourned at 4:31 p.m.

ITEM 5-INFORMATION

YOUTH LEADERSHIP FORUM FOR STUDENTS WITH DISABILITIES

BACKGROUND:

In October 2023, The SETA sponsored a weekend-long Youth Leadership Forum for Students with Disabilities (YLF), in partnership with the California Department of Rehabilitation, Alta Regional Center, Resources for Independent Living, Sacramento City College, Association of California State Employees with Disabilities, SMUD, and CalVoices. The YLF event included 17 in-school youth.

The SETA Youth Team leveraged the event to provide leadership training opportunities to the students enrolled in the Student Training and Employment Program for Students with Disabilities (STEP). There were opportunities for work-based learning and pathways to success by connecting youth to resources and services to keep their personal, educational, and career goals. The program, rooted in self-advocacy, allowed youth to explore their vision of the future by creating art projects that displayed their aspirations. Some highlights of this first event included connecting youth to form a community, opening a world of possibilities and opportunities for youth to explore the future, and enriching the lives of the youth of Sacramento. We had guest speakers like alums from the statewide program, mental health organizations, and a visit from the Sacramento Mayor, Darrell Steinberg. Attached is the promotional flyer.



DAS has convened the **California Youth Apprenticeship Committee** (CYAC) to develop recommendations to the division on the expansion of youth apprenticeships in California. In developing these recommendations, the committee shall specifically address the following topics:

- Clear definitions of youth apprenticeship and high school apprenticeships.
- Guiding principles in the CA Opportunity Youth Apprenticeship (COYA) Grant Program.
- Insights on the structure of the state's work to expand youth apprenticeship.

The committee shall provide a report to the division with a set of recommendations no later than July 1, 2024.

The committee includes representatives from youth, youth serving organizations, labor, employers of youth, K-12 schools, community colleges, and the public 19, 2023 workforce system.



CA Apprenticeship Initiative Grants

Program Planning Grant

- Up to 1 year grant term.
