4. Information: SCUSD Out-of-School and City of Sacramento In-School Youth WIOA Youth Program Site Tour and Presentation

Youth Committee Members and staff toured the Charles A. Jones Career and

### Education Center facility.

Ms. Martinez advised that SCUSD Out-of-School and City of Sacramento In-School Youth programs are enrolling and have slots available. Ms. Mechals asked members to refer those who are interested.

The SCUSD Out-of-School Youth Program is for 18-24-year-old low-income individuals with limited or no work experience, deficient basic skills, and not attending any school. The program provides the following services:

- High School Equivalency Certificate;
- Post-secondary education and training;
- Paid and unpaid work experience;
- Comprehensive guidance and training;
- Leadership development activities;
- Occupation skills training;
- Financial literacy;
- Job search assistance.

The City of Sacramento In-School Youth Program is for high school seniors for School Year 23/24 who graduate no later than June 2024, are eligible for a work permit, and are low-income. This program provides services to eligible individuals with one or more of the following barriers:

- Basic skills deficiency;
- English language barrier;
- Post-offender;
- Foster care recipient;
- Homelessness;
- Disability.

### 5. **Information:** Youth Leadership Forum for Students with Disabilities

Ms. Mechals advised that in October 2023, SETA sponsored a weekend-long Youth Leadership Forum for Students with Disabilities (YLF), in partnership with the California Department of Rehabilitation, Alta Regional Center, Resources for Independent Living, Sacramento City College, Association of California State Employees with Disabilities, SMUD, and CalVoices. The YLF event included 17 in-school youth.

The SETA Youth Team leveraged the event to provide leadership training opportunities to the students enrolled in the Student Training and Employment Program for Students with Disabilities (STEP). The program offers work-readiness and job placement/work experience.

Mr. Rocha-Rosario provided more in-depth information on the STEP program. The presentation is attached to these minutes.

Ms. Mechals confirmed that SETA deploys its navigators to off-site locations, also known as satellite sites. She shared the success story of one of the program participants who got a degree in Early Child Education, gained work experience, and is now working for SETA Head Start as an Associate Teacher.

Individuals can learn about the STEPS program through social media and school district contacts such as workability coordinators and teachers.

When youth graduate from the program, they either return to school or are transferred to another program.



# Kekoa C.

2022-2023 Program Participant



Kekoa is a 19 year old resident of Sacramento County. He entered the STEPS program when he was a senior in high school. Kekoa enrolled in the program after he learned about it through his best friend, who knew he was searching for work.

Kekoa enjoyed being part of the STEPS work readiness training and work experience because it gave him the skills to excel in areas he had barriers with before. Kekoa states "The STEPS program allowed me to overcome and prepare for many challenges I thought I would face going into [the work experience]." The STEPS program helped Kekoa overcome his social anxiety and helped him to develop better social skills. While in the STEPS program, Kekoa was able to utilize his new social skills at his work experience placement, Grocery Outlet. Kekoa's supervisor expressed every time that Kekoa is one of his best workers stating, "he is very independent, reliable, and hard working".

Kekoa was hired on as a permanent employee two weeks before he graduated high school. He is currently employed by Grocery Outlet and also enrolled in Cosumnes River College with goals of completing and going into government.

# Candace S.

2023 - Program Participant



Candace was a 17-year-old Sacramento County resident attending high school when she learned of the STEPS Program from her school. She had been wanting to get her first job and wanted to work but she lacked confidence due to her stutter.

Upon learning about STEPS, Candace enrolled and received work readiness training. Upon the completion of training, she received a \$200 Target gift card to assist her in buying work attire for her interviews. Through Candace's weekly engagement with STEPS she quickly built a good working relationship with her Workforce Coach, Ms. Rebecca. Ms. Rebecca even sat with Candace during her interview to help show Candace that her stutter wouldn't even be a barrier. Candace gained new confidence once she realized she could do it. Candace was placed in a paid work experience at Baskin Robins in Elk Grove, where she had the opportunity to gain a variety of skills while continuing to build confidence in her communication. Candace received workplace training for her role and received feedback from her worksite supervisor and workforce coach on how she was doing.

Upon completion of her paid work experience, Candace was offered a permanent role as a Cake Decorator and was hired directly by the owner. Candace said, "The STEPS Program helped me prepare for work because it introduced me to proper interview etiquette and educated me on how to respond to my employer in a professional way. In addition, the STEPS Program Coaches were extremely welcoming and nice which made me feel safe. They worked hard finding me a job, which I very much appreciate."

# California Youth Apprenticeship Committee

DAS has convened the **California Youth Apprenticeship Committee** (CYAC) to develop recommendations to the division on the expansion of youth apprenticeships in California. In developing these recommendations, the committee shall specifically address the following topics:

- Clear definitions of youth apprenticeship and high school apprenticeships.
- Guiding principles in the CA Opportunity Youth Apprenticeship (COYA) Grant Program.
- Insights on the structure of the state's work to expand youth apprenticeship.

The committee shall provide a report to the division with a set of recommendations no later than July 1, 2024.

The committee includes representatives from youth, youth serving organizations, labor, employers of youth, K-12 schools, community colleges, and the public 15, 2024 workforce system.



# Youth Apprenticeship Funding

### **CA Apprenticeship Initiative Grants**

### **Program Planning Grant**

- Up to 1 year grant term.
- Up to \$120,000 per award.
- To be used to develop a plan to create new apprenticeship programs or pre-apprenticeship programs and to register those programs with DAS.

### **Program Implementation Grant**

- Up to 3-year grant term.
- Up to \$1,500,000 per award.
- To be used to implement a recently DAS-registered pre-apprenticeship program or apprenticeship program.

### **Apprenticeship Program Expansion Grant**

- Up to 2-year grant term.

### APPROVAL OF THE APPPOINTMENT OF YOUTH COMMITTEE MEMBERS

### BACKGROUND:

The Youth Committee has developed the following plan to engage youth in all Sacramento Works activities, including the Youth Committee.

### Action Plan:

- 1. Prioritize the need to pay youth for taking on a leadership role.
- 2. Focus on engaging younger individuals, 16-24 to help with program design, community outreach, and committee planning of activities.
- 3. Provide youth voice and expertise, power, and share in decision-making with adults.
- 4. Redesign the Youth Committee Application. The paid work-based learning opportunity Job Description will include the application link.
- 5. Compensate youth for time worked at approximately 10 hours per month. The California Community College Foundation will be the employer of record.
- 6. The goal is to provide 10 work-based learning opportunities.
- 7. Funded by WIOA Youth Committee Initiatives \$50,000

In February 2023, staff developed marketing tools and an application process as well as promoted the opportunity to the youth providers during the provider trainings. The application remains open through December 2024. Application <u>link</u>.

The Youth Committee introduced the following four new applicants at its December 19, 2023 meeting. All have been recommended for appointment by the Youth Committee Chair, Mr. David Gordon:

- Ivan Horta Youth Voice Advocate with SETA WIOA Youth Program
- Maura Perez-Lima Youth Voice Advocate with SETA WIOA Youth Program
- Jazlyn Mosley- Youth Voice Advocate with SETA WIOA Youth Program
- Jennifer Christine-Madamba- Education Specialist, Regional Workforce Development with SMUD

# CONSIDERATION OF SPONSORSHIPS – CONSTRUCTION INDUSTRY EDUCATION FOUNDATION (CIEF) – DESIGN BUILD COMPETITION AND SACRAMENTO REGIONAL YOUTH CAREER FEST

### **BACKGROUND:**

The 2023-2024 Youth Program budget includes \$50,000 allocated for Youth Committee Special Initiatives. These funds are used to support the hiring of Youth Voice members, community outreach events, youth workshops, job fairs and event sponsorships.

The CIEF Design Build Competition® will be held May 1-2, 2024. It promotes career awareness of the construction industry among high school students through hands-on experience in the construction process and a first-hand look at future opportunities in the industry. As it recognizes student ingenuity and achievement, the competition allows the construction industry to support, partner with, and mentor schools, students, and career technical education programs. Each participating team is challenged to design, plan, and construct a 96 sq. ft. structure that meets a set of criteria established under the advisement of industry professionals. Through sponsorships and grants, teams compete at no cost to any student or school.

CIEF will be welcoming 44 high school teams, to build a structure such as a greenhouse, playhouse, micro-home, or shed-like structure. This workforce development program helps to educate and excite the next generation about careers in the industry while obtaining the skill sets for work in the field upon graduation. Many teams will donate their structure to a nonprofit in their community, utilize it on their campus, or sell it to fund their woodshop program.

Thanks to industry sponsors, CIEF can provide this event free of charge to all students and schools. All sponsorships and donations over \$500 will receive logo recognition. All sponsorships go to support event costs including safety gear and OSHA training, building materials, and scholarships.

The 2024 Sacramento Regional Youth Career Fest (SRYCF) is an inaugural event to connect, inspire, and begin to equip 500 Sacramento Region High School students for a wide variety of careers. SRYCF was created by two local 501(c)(3) nonprofits: Interns 2 Pros and Mending of Mothers, Inc. They have partnered with Cosumnes River College (CRC) to host this inaugural event, and the Sacramento City Unified School District to sponsor the attendance of 200 students from the Career Technical Education (CTE) district-wide program. The SRYCF will also feature 300 additional diverse students from other school district partners and institutions.

This event will primarily serve students from historically excluded and often forgotten groups across the Sacramento region, with the majority living in the federally designated

Sacramento Promise Zone, Opportunity Zone, and California-designated Disadvantaged Communities.

Students will learn from and connect with companies in skilled trades, solar, tech, sports, media, hospitality, Government, retail, and those with a zero carbon focus.

All sponsorships and donations over \$500 will receive logo recognition, vendor table, and meals for team members. Other sponsorship opportunities:

**Event sponsorship:** Monetary contribution to assist with reducing the cost associated with producing this event.

**Volunteer sponsorship:** Engaging with and encouraging employees to volunteer at the SRYCF.

**In-Kind sponsorship:** Contributing services and/or products to assist toward the production of this event. The value of the in-kind donations should be equal to the sponsorship incentive tiers. SRYCF is happy to receive in-kind donations in the forms of: *swag bag contents, scholarships, transportation, etc.* 

### RECOMMENDATION:

Discuss the sponsorship requests and take appropriate action. Staff recommends allocating a total of \$2,000 in Youth Committee Initiative funds – 1) \$1,000 for a bronze sponsorship of the CIEF Design Build Competition and 2) \$1,000 for the Sacramento Regional Youth Career Fest (SRYCF). The events will be staffed by the SETA WIOA Youth Providers, Youth Voice Committee Members, and SETA/Sacramento Works Workforce Development Professionals providing career pathway information and work readiness resources to event participants.



The 2024 Sacramento Regional Youth Career Fest (SRYCF) is an inaugural event to connect, inspire, and begin to equip 500 Sacramento Region High School students for a wide variety of careers.



Students will learn from & connect with companies in skilled trades, solar, tech, sports, media, hospitality, Government, retail, and those who have a zero carbon focus.

SRYCF was created by two local Sacramento 501(c)3 nonprofits: Interns 2 Pros and Mending of Mothers, Inc.
