ITEM 2- CONSENT

APPROVAL OF FINDINGS AND AUTHORIZATION TO EXTEND USE OF TELECONFERENCING PROCEDURES FOR BOARD MEETINGS DURING DECLARED STATE OF EMERGENCY AND/OR WHILE STATE OR LOCAL OFFICIALS CONTINUE TO IMPOSE OR RECOMMEND MEASURES TO PROMOTE SOCIAL DISTANCING

BACKGROUND:

California Governor Gavin Newsom has issued long-existing state of emergency related to COVID-19, which remains in effect. Governor Newsom had previously authorized local agencies, by Executive Order, to conduct meetings under the Brown Act utilizing Zoom or other remote procedures to conduct meeting by modified teleconference procedures. In September 2021, the legislature signed and passed into law AB 361, which amended Section 54953 of the Brown Act to similarly authorize teleconferencing of Board Meetings, provided necessary procedures are followed.

Under AB 361, in the event of disruption which prevents broadcasting of the meeting to members of the public using the call-in or internet-based service options, or in the event of a disruption which prevents members of the public from offering public comments, the legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting is restored.

AB 361 also authorizes public agencies to continue to hold subsequent meetings via teleconference procedures during any state of emergency that directly impacts the ability of the members to meet safely in person or while State or local officials continue to impose or recommend measures to promote social distancing. The Governor's declared continuing state of emergency remains active and continues to serve to protect members of the public from unnecessary risk and exposure to COVID-19. In addition, Cal OSHA continues to recommend physical distancing in places of employment as a measure to protect employees against the spread of COVID-19. Given these circumstances, in order to allow for the next Committee meeting to be held by teleconference procedures consistent with AB 361, the Committee must make the following findings no later than 30 days after the first teleconferencing meeting and every 30 days thereafter by majority vote:

- a. The legislative body has reconsidered the circumstances of the state of emergency.
- b. Any of the following circumstances exists:
 - i. The state of emergency continues to directly impact the ability of the members to meet safely in person.
 - ii. State or local officials continue to impose or recommend measures to promote social distancing.

1. **Call to Order/Roll Call:** Mr. Gordon called the meeting to order at 1:12 p.m. The roll was called and a quorum was not achieved.

No action was taken for the Consent or Action items due to lack of quorum.

4. <u>DISCUSSION/ACTION ITEM:</u> Review of the Draft RFP for the WIOA Youth Program

Ms. Mechals reviewed the focus areas of the draft RFP. She asked the Committee if we are headed in the right direction with the focus areas.

Ms. Stephens suggested cultivating applications with providers beyond the City of Sacramento boundaries, such as the Galt area.

Mr. Gordon commented on the need for services in the outlying areas such as the River Delta area, Isleton, Walnut Grove and Galt.

Ms. Mechals replied during the last WIOA public input meeting in November 2023, the California Human Development that operates the Galt Job Center provided input on expanding their programing and serving both in-school and out of school youth.

Mr. Gordon commented it would be beneficial to reach out to the one school in Galt to see if they would like assistance.

Mr. O'Briant commented Sacramento County does service the River Delta area schools in the Rio Vista area through their workability grant. There could be an opportunity to bridge services between SETA and SCOE to service those areas.

Mr. Gordon commented there is a need to increase preparation for public service occupations. There is a great need for teachers. We are also short on mental health professionals to address those needs.

Mr. Gordon stated one of the barriers for underserved youth is there are not enough internship or apprenticeship opportunities that will sustain the youth without supplemental support from family or additional work. He would like to see a program with SETA to address these needs. Ms. Stephens agreed.

Ms. Stephens commented for these programs traditionally the efforts go towards volume of youth served. What flexibility do we have to utilize WIOA dollars for a program?

Ms. Mechals replied there is flexibility. It is up to the organization to build it into their plan. It is up to the providers to set the wage rate.

Mr. O'Briant commented SCOE has a transition partnership program in collaboration with the Department of Rehabilitation. They have expanded all their WEX to 300 hours per given position.

Ms. Ross commented the challenge with in-school youth programs is scheduling availability to students. There is a need for paid internships with hours beyond the standard eight to five, due to the school hours.

Ms. Mechals asked Ms. Martinez what are the trends and challenges she is seeing from providers in regards to WEX.

Ms. Martinez replied the current challenge is predominantly wages. Youth are looking for more remote work. Their work expectations have changed, reflecting digital literacy changes. There is a shift that is needed to more in-person work. We do see a struggle in finding jobs for youth that are open after 5:30 p.m. that are not fast food opportunities. Youth also need more hours beyond simply weekends, as working weekends does not provide enough hours.

Ms. Ross commented the independent study programs are currently highly impacted. Another question is if there are virtual internships. With virtual internships there is a gap in workability and employability skill with no one directly there to correct the intern.

Mr. Gordon asked about schools changing their structures or hours to allow for youth to be off campus for a day or two a week to intern and acquire in-person experience.

Ms. Ross stated a work experience program has worked in the past. It is staff heavy, but effective. These programs allow for the youth to receive high school credit and earn wages.

Mr. Gordon suggested to put an indication in the RFP to welcome proposals from providers who support similar programs.

Ms. Mechals commented it would be good to expand partnerships with business and employers.

Ms. Martinez commented the programs are focused towards youth in their Junior and Senior year of high school, which can allow for more flexibility in their schedules.

Ms. Ross commented it has been worked into capstone courses.

Ms. Stephens suggested if there is flexibility in the RFP programing dollars to reserve some dollars to help support partnerships. What if the providers develop the employer relationships prior to receiving the dollars.
