APPROVAL OF OUT-OF-STATE TRAVEL TO ATTEND A U.S. DEPARTMENT OF LABOR EMPLOYMENT AND TRAINING ADMINISTRATION (ETA) CONVENING

BACKGROUND:

The U.S. Department of Labor's (DOL) Employment and Training Administration (ETA) is hosting a convening in Crystal City, VA, on May 16-18, 2023. This convening will provide an opportunity for the public workforce system to come together to ensure that the DOL's efforts help support an economy that works for all. This convening will be an opportunity to highlight and uplift existing programs, build partnerships and break down silos, catalyze success by scaling up, and create strategic plans to meet future needs. In service of this important work, ETA will share its vision for the next decade, focused on four guiding pillars:

- Expanding Opportunities for Underserved Workers and Communities
- New Industry Partnerships that Lead to Real, Good Jobs
- Build a Better Care Economy
- Action Today for the Future of Work

Attendees will include representatives from state and local workforce boards, education and training providers, state workforce agencies, community colleges, employers, unions, industry associations, training intermediaries, philanthropy, community-based organizations, academic researchers, and federal and other government partners.

Approval is sought to send Jennifer Hernandez, Executive Director, to the U.S. Department of Labor ETA convening.
