# IV. Information Items:

#### A. Community Action Month

Ms. Scott presented the item. She advised that the National Community Action Partnership hosts an annual Community Action Month in May of each year. SETA proposes to participate in Community Action Month by hosting a Resource Fair at SETA with Participation of the 2024 Community Service Block Grant Delegate Agencies. Ms. Scott asked the Board members and the Agencies they represent to participate in the Resource Fair. SETA staff is seeking feedback on the Community Action Month proposal.

Ms. Scott provided the following details about the event:

- The goal of the Resource Fair is to highlight different resources and Agencies to the public and promote the communities we serve;
- There has yet to be a set date. SETA staff will inquire about Board members' availability to select the date in May;
- Resource Fair will be open to anyone to attend.

Mr. Starks noted that the Resource Fair will be excellent for SETA's public relations. He suggested making the event well-advertised to attract the public and having workshops in the breakout rooms.

Ms. Wash suggested extending the Resource Fair idea to a whole month of community-oriented workshops, activities, site visits, etc.

Ms. Espinosa suggested collaborating with Los Rios Community Colleges, Sacramento State University, UC Davis, and SacRT. She also stated that holding the event on weekend days would result in better public attendance.

Mr. Coyl stated that he will explore the possibility of having this event at the Central Library in Downtown Sacramento, which can hold up to 400 people and other partnership opportunities.

The Board spoke positively about the Resource Fair idea and intends to collaborate and participate.

Further updates will be provided at future meetings.

B. Community Services Block Grant Fiscal Monitoring Reports:
 Ms. Dozier asked for an update on the monitoring report findings for Rose Family Creative Empowerment Center, Inc. (Rose Family).

Mr. Maslac introduced himself and confirmed that the Rose Family addressed all the items on the report at the end of last year as they provided requested documentation.

Ms. Davis-Jaffe shared that 2024 CSBG contracts are being processed. The providers are on board with submitting contracts in a timely manner to SETA. Providers are in place to start the services. She thanked the Board members for their attendance at today's meeting and advised that there is one low-income vacancy on the Board. The Head Start Policy Council will elect one of its members during January's Policy Council meeting to fill that vacancy.
