Ms. Clawson reviewed the draft agenda for the Sacramento Works, Inc. Board meeting scheduled for January 28, 2026.

Ms. Maldonado mentioned that she will provide an update on the recruitment for the Deputy Director position in the Workforce Development Department.

Mr. Cunningham confirmed that there is no conflict of interest regarding Mr. Nye and Mr. Stewart serving on the Sacramento Works Board and the Governing Board, respectively, even though they work closely together at the Los Rios Community College District.

Ms. Clawson indicated that she will address committee attendance and the election of new officers for 2027.

Ms. Maldonado advised that Ms. Tarianna Perez, SETA's Public Information Officer, will be leaving the Agency in the middle of February, and recruitment to fill this position is underway.

III. INFORMATION ITEM:

A. Board Membership Updates:

Ms. Maldonado spoke about Ms. Janna King, who submitted her qualifying application to be appointed to the Sacramento Works, Inc. Board, and shared her professional highlights. Mr. Cunningham recommended adding an action item for Approval of Appointment Recommendation to the Sacramento Works, Inc. Board's agenda for the upcoming meeting on January 28, 2026.

IV. STAFF REPORTS:

Ms. Maldonado and Ms. O'Camb reported that the Refugee Program underwent a success review, during which six out of ten employment service providers and 144 records were reviewed, with zero errors or observations noted.

Ms. Maldonado announced that SETA's Community Service Block Grant (CSBG) Program has received funding for the first quarter of the year. Furthermore, SETA has been awarded \$8 million through the Proposition 47 Cohort 5 Grant Funds. In this role, SETA serves as the fiscal agent, assisting citizens returning from incarceration with mental health services and employment opportunities.

Ms. Mechals highlighted an internship partnership with the Los Rios Community College professional health program for out-of-school youth aged 18 to 24.
